

# **Grant Resources**

Although grant funding can never be a guaranteed resource for your organization, applying provides access to and opportunities for much needed spay/neuter subsidies in specific targeted areas and demographics. Before applying for any grant, make sure you read the guidelines of the grantor and ensure that you will fall into their funding categories.

**Albert Schweitzer Animal Welfare Fund** provides funding to U.S. based 501(c)(3) organizations that promote humane education, humane sheltering, and solutions to overpopulation and animal protection.

American Humane Association administers the Meacham grant to 501(c)(3) organizations and the Second Chance Fund to both public and private shelters or rescues.

**Animal Farm Foundation** offers grants for adoption, enrichment and other programs for 501(c)(3) organizations focused on supporting pit bull type dogs by providing equal opportunities and treatment.

**ASPCA** grants provide support to U.S.-based non-profit animal welfare organizations through cash awards, sponsorships, executive and technical assistance, and training. Grant areas include emergency and disaster response; equine fund; anti-cruelty response, prevention and training; support to for live release, spay/neuter and relocation programs; and, conference sponsorships and scholarships. **Banfield Charitable Trust** funding priorities focus on programs that provide a direct solution to avoid surrender or separation of companion pets (including equine programs) from families.

**Bernice Barbour Foundation** were established to fund organizations which provide hands-on care for animals, and spay/neuter programs to protect, preserve, and nurture companion animals, large animals, native wildlife, and marine species in the United States.

**The Binky Foundation** prioritizes seed funding for new programs or equipment purchases promoting animal protection and habitat preservation, and also considers funding for long-term or ongoing projects. 501(c)(3) not required.

**The Bissell Pet Foundation** provides financial support to programs of municipal and 501(c)(3) organizations focused on adoption, spay/neuter, microchipping, foster care, and safety nets. Funding also considered for emergency relief in addition to hoarding and puppy mill rescue efforts.

**Cats R Cool** provides funding for enrichment items, vaccines, and spay/neuter for cats, as well as renovations of cat rooms.

**Edith J. Goode Residuary Trust** reviews proposals from humane societies seeking scholarship support for staff training in nonprofit management (with a focus on shelters) or organizational surveys of animal demographics and trends in shelter numbers, indicating how this data will be used to develop more effective programs. Proof of 501 (c)(3) status is required.

**Elinor Patterson Baker Trust** offers grants four times a year and is looking for innovative, new programs, especially those that feature outreach and engagement. Partnerships with other groups are also a plus. For information contact your local HSUS state director by e-mailing [yourstate]@hsus.org.

**Greg Biffle Foundation** provides funding for operating expenses, pet supplies, spay/neuter and veterinary care for active 501(c)(3) organizations that deal with dogs and cats.

**The Grey Muzzle Organization** provides grants and special programs for 501(c)(3) organizations whose activities include helping senior dogs.

**Gus Hawthorne Foundation** provides financial assistance to 501(c)(3) organizations with the mission of providing care for abused, abandoned, feral, at-risk domestic or exotic animals or care and release of injured/orphaned wildlife.

The Kenneth A Scott Charitable Trust invites proposals from active 501(c)(3) humane organizations based in the USA for projects designed to enhance the well-being of animals in Ohio, elsewhere in the Great Lakes region(IL, IN, MI, WI, Western PA, Upstate NY, and Northeastern MN), or in the Nation as a whole.

Laura J Niles Foundation funds 501(c)(3) organizations, primarily in the Northeastern U.S., with initiatives that support people and animals simultaneously. Areas of concentration include canine health research, animal protection & adoption, search & rescue training, human assistance and similar fields of interest.
